MESSAGE FROM THE POTENTATE



Greetings Nobles,

During my tenure on the Divan, I have referred to excerpts from the Shriners Creed. I have done this to try and convey the intent of the principles of the order. In other words, the Shrine does not exist for the pleasure or benefit of any individual or group of individuals. Simply, it is not what the Shrine can do for you, but what we all can do to make it prosper. Those of us who work and have contributed to the system for many years are upset when benefits are given to those who have done nothing to help themselves and are looking for a hand out. The Shrine was not established as a welfare organization. Nowhere in the Shriners Creed can one find the words I or me. Every principle begins with the word we, Shriners or brothers. I encourage everyone to read the Shriners Creed in its entirety and focus on "WE."

The membership of our order is in decline. Membership is approximately one third of its highest point. Every candidate for the Imperial line has stated in their platform that membership is the key for growth. The leadership at Imperial spends a lot of time and money developing plans to increase membership. The Shrine is even expanding into foreign countries. So, why is membership continuing to lose ground? The fast paced society we live in has trained us to expect instant gratification. The people who teach development classes at Imperial realize the following examples are a part of the problem. When a new noble is brought in to the order and does not see anything that peeks his interest he is lost. Furthermore, they don't have time for temple politics, personalities and egos. Again, I reference the Shriners Creed and the emphasis on "WE".

In December, we will be electing officers for the ensuing year. There are many criteria that may be used to determine if someone qualifies to lead the temple. Membership being an issue the one that stands out is being financially secure, to the point that one's job requirements do not interfere with temple obligations. A lot of us remember the days when there was ample help to take care of whatever was going on at the temple. Today we can't get enough help to work Bingo and other functions. Consequently, the Divan has had to assume as much of that responsibility as possible. An unnecessary burden is put on other Divan members, if a person who "works for the man" can't do their part.

Finally, I want to thank those who have helped my lady and me this year. Due to health issues, it has been and continues to be a difficult time. Your hard work and sacrifice of personal time and in some cases dollars is greatly appreciated.

The holidays are quickly approaching. My lady and I hope everyone has a safe and happy holiday season. Consult the temple calendar for upcoming events.

Greetings Nobles,

Today, we must make a choice that may not be a popular one. We must all mark a defining moment in the reassembling of the Alcazar Temple. In the face of declining membership, lack of membership participation and economic breakdown, the Alcazar Temple is struggling to operate efficiently. It is

imperative that your board of directors, we the elected divan, reach an agreement with you, the Nobles quickly and fairly. The agreement must allow your divan to launch a leaner, focused and cost effective New Alcazar Temple.

The elected Board of Directors is devoted to you, the nobles, the ladies, as well as the Shriners' cause. There is no other way to say it, "we have to pursue and launch a New Alcazar Temple". The New Alcazar Temple will have a dramatically stronger balance sheet, with far less debt, which will allow us to better invest in our children and temple's future.

From day one the new revamped Alcazar Temple will have the ability to generate a sustained and positive bottom-line performance. The Board of Directors deeply appreciates the support and the demonstration of confidence you have given us thus far. We now ask you to sacrifice and trust us while we work to reinvent the Alcazar Temple. We are focused on the job at hand, for the benefit of our current and future nobles and ladies as well as the new profitable Alcazar Temple.

There are pros and cons to this controversial issue at hand. I have received numerous calls on my position of the issue and have conversed in person with current and past Potentate. I have contemplated with an open and sober mind. I will make this clear that I will not support nor be in favor of the Alcazar Temple to move out of Montgomery, Alabama. My reasoning is simple Montgomery is the center part of Alcazar's jurisdiction. However, I am in full support to streamline the operation of the Alcazar Temple to a building that fits our needs. We currently have approximately 1,000 members. We

have about 10% turn out on elections, maybe 5% show on called meetings, and less than that on temple functions. I do understand the rental income is a major return for the Alcazar Temple. However, the return does not match the outgoing reoccurring expense. In a business sense this formula has no merit. Each year right off the top the Alcazar Temple spends \$100,000.00 for power and insurance. That's before any fundraisers are started.

All our buildings are in need of major structural repair from leaks to termite damage not to include hidden problems not yet discovered. Currently we have temple building issues that are about \$200,000.00 in repairs. Now the board of director's can spend and rectify the problems and keep the current aged Alcazar Temple doors opened for the 10% who visit. But prove to me and/or show me a plan of why we should be doing this.

I was questioned by a past potentate last week as to what side I'm on in reference to sell and move or fix and stay. I answered "I am on the side of right" I also responded that "I was elected by the nobles to be fair, honest and unbiased in all my actions when dealing with the temple". I expressed to him that it was not fair to ask me or any other brother noble to choose a side merely on his opinion alone.

I'm obligated to approximately 1,000 members and their ladies. Yes, you read correctly "ladies" I will also listen to our ladies; their opinion matters to me. The Alcazar Temple is as much theirs as yours or mine. Remember our ladies are a vital part of our functions therefore I owe it to them to listen to their concerns and fears.

My conclusion is "fix the problem". Act now and scale down to a building that fits our needs. The key phrase is "fit's our needs". Or let's move forward to correct the Alcazar Temple's structural damage and problems and stay on the hill. I care deeply for the Alcazar Temple. However if we fail to act now or reach an agreement I am afraid there will not be an Alcazar Temple for our future nobles and ladies

*** RESOLUTION ***

Disposal of ALCAZAR Property

From time to time, certain property at the ALCAZAR Center, and ALCAZAR Clubs, wears out, becomes damaged, broken, surplus, etc., and it is in the best interest of the Center and/or Club to properly dispose of same.

A. CENTER

- 1. Any property in the forgoing shall be thoroughly inspected by the Divan, and a listing provided to the ALCAZAR membership at a regularly scheduled business meeting (except the December meeting), describing the exact condition of the property.
- 2. The Potentate shall request permission of the members in the nature of the disposition: i. e., sell, possibly repair, transfer to a Club or Unit, junk etc. The vote by the membership shall constitute the authority to proceed.
- 3. If request is to sell, the Potentate shall properly advise the membership by publishing in the ALCAZAR NOBLE newsletter (or other media), an ad containing a full description of the item(s) location and condition requesting sealed bids by a specific date for purchase. On the bid date, the sealed bids will be opened by the Potentate, Recorder and Treasurer; and award will be made to the highest bidder. Payment by bidder will be by cash or check, and deposit of the funds will be to the General Fund (or Club fund, if appropriate).
- 4. Any property categorized as other than "sell" shall be jointly be handled and processed by the Divan

B. CLUBS

- 1. For any property heretofore described, the Club(s) shall request permission from the Potentate to dispose, and the information in A1, 2, and 3 above shall be followed, except that Club Officers shall inspect the items involved and submit a report to the Potentate for disposition. Proceeds shall be retained by the Club(s) involved unless otherwise directed by the Potentate.
- 2. Any property in categories other than "sell" shall jointly be handled and processed by the Club(s) Officers.

In accordance with ALCAZAR by-laws, the Potentate shall give a report to the membership at the ALCAZAR Annual Meeting in January, detailing the disposition of all such properties.

The World's Largest Peanut Boil

Crenshaw County hosted the world's largest peanut boil, over the holidays. Noble Andy Compton and the nobles from Crenshaw County work diligently to prepare, boil, bag and sell, over 50 tons of peanuts. This is no small accomplishment.
